

2日本遊客馬尼拉遭槍殺 觀光客卻步夜生活陷冷清

本報綜合外電報道：兩名日本遊客上週在馬尼拉夜店區遭槍殺，引發外籍遊客和僑民對安全的憂心，許多人暫時不敢外出，尤其日本人受影響最為明顯，導致夜店與餐廳生意驟降。

15日晚上10時40分，2名日本遊客由導遊陪同，搭計程車抵達馬拉地地區（Malate），剛下車就遭1名歹徒近距離槍殺，另1名同夥趁亂取走受害人的隨身物品後，和槍手騎機車逃逸。

警方迅速馳抵展開追捕，雙方一度僅相

差不到10秒，但嫌犯仍利用錯綜複雜的巷弄成功脫逃。

經過後續追查，馬尼拉警方19日宣布，3嫌已有2人落網，即導遊和槍手，兩人是兄弟關係。初步調查顯示，主謀人在日本，疑因金錢糾紛以900萬披索代價買凶。

在案發現場，有人擺放白色鮮花、礦泉水與零食，悼念遇害遊客。

馬拉地地區以夜生活聞名，雖然面積僅0.59平方公里，卻聚集16家飯店和眾多餐廳、酒吧和卡拉OK店，是日、韓、台與中國遊客

常到訪之地。

然而，凶殺案重挫馬拉地地區安全形象，儘管霓虹燈依舊閃爍，街頭卻冷清不少，平日忙於攬客的夜店員工，只能無奈在店門口踱步。

夜店經理卡洛爾告訴外媒，近期客人明顯減少，凶殺案是主要原因，許多觀光客選擇晚上待在家中。

她補充，一些日本公司提醒日籍員工避免夜間外出；部分旅館也接獲日本遊客取消訂房的通知。

業者希望警方盡快破案，恢復遊客信心。

為加強維護治安，馬尼拉市警察局已增派20多名警員到馬拉地地區，主要路口均有警員駐守，警車巡邏也更頻繁。

馬尼拉市警察局發言人伊里斯接受外媒訪問時強調，這是一起個別事件，歹徒在日本策劃，由同夥在菲律賓執行，並非隨機搶劫案。

伊里斯說，警方將加強巡邏力道，確保外國遊客與商人的安全。

亞謹諾籲在腐敗問題中 繼續追尋尼蕊良政願景

本報訊：8月21日週四，參議員保羅·「巴姆」·亞謹諾四世（Bam Aquino）在尼蕊·亞謹諾國際機場第一航廈舉行的前參議員小敏勒諾·「尼蕊」·亞謹諾（Benigno「Ninoy」Aquino Jr.）逝世42週年紀念獻花儀式上，呼籲菲律賓民眾團結起來，在腐敗爭議持續困擾國家之際，共同追尋已故參議員的良政願景。

亞謹諾表示：「這正是他當年奮鬥的目標——良政與社會公平，我們深知這些尚未實現。如今，我們再次面臨相似處境。」

他所指的是近期參議院藍帶委員會調查的涉嫌異常防洪工程爭議。

他說：「民眾的參與及對國家與全民福祉的追求至關重要。」

亞謹諾進一步指出，菲律賓人民渴望的改革無法單靠一人完成，唯有透過團結與集體努力方能實現。

他說：「我們需要團結一致，必須共同奮鬥。」

他同時敦促民眾勿忘其叔父的遺產與犧牲，正是這些奠定了國家民主恢復的基礎。

I. Introduction to Talugtug Renewables Inc.

Talugtug Renewables Inc. (hereinafter referred to as "the Company") is a legally registered power - operating enterprise in the Philippines. Its main business is the production and operation of the 99.96MW photovoltaic project in Talugtug, the Philippines.

II. Inquiry for purchase content

1. Rent one GAC Trumpchi GS8 for a one - year lease term. The vehicle should be regularly maintained and in good condition. It must be fully insured, including passenger insurance. There should be no record of major overhauls, and the mileage should not exceed 100,000 kilometers. During the lease period, the vehicle must be parked at the location designated by our company. All vehicle maintenance and repair costs during the car - rental period shall be borne by the car - rental company.

2. Provide one driver who should meet the following requirements: be under 55 years old, have rich experience, hold a legal driving license, have a driving experience of no less than 10 years, and be insured with driver's insurance. The car rental company shall not replace the driver arbitrarily without the consent of our company.

3. The main working locations for the driver are Rosales City in Pangasinan Province, Talugtug City in Nueva Ecija Province, and the surrounding towns and regions. The driver is required to abide by the company's accommodation arrangements. Meanwhile, the driver should

live within a one - hour living circle of the BGC area in Manila. During the working period in Manila, the driver, living at their own home, needs to arrive at the designated working area in BGC at 8:30 a.m. every day to wait for tasks. The working days are from Monday to Saturday, with Sundays and Philippine legal holidays off. The travel expenses for the driver to and from the project during their days off shall be borne by the car rental company.

4. The company is currently in the construction period of the solar power plant and needs to travel to the project site frequently. The driver is required to have strong physical fitness and be able to follow the company's travel arrangements. In case the driver fails to comply with the arrangements, the car rental company should replace the driver immediately as required by the company.

III. Qualification requirements

1. The service provider should be a company legally registered in the Philippines.

2. Suppliers with an interest - related relationship with the purchaser that may affect the fairness of the procurement are not allowed to submit quotations. Different entities with the same person as their responsible person or those with holding or management relationships shall not submit quotations simultaneously.

IV. Registration and review

This tender adopts the method of the lowest evaluated bid price (excluding bids below cost). Quotation documents that do not meet the evaluation requirements will not be evaluated.

After evaluating the response documents of each supplier in accordance with relevant regulations, the purchaser will select the supplier meeting the following conditions as the winning supplier:

1) Pass the qualification review;
2) The response document substantially complies with the requirements of the procurement document.

The purchaser does not guarantee that the lowest - priced bid will be the winning one, nor will it explain the reasons for non - winning bids.
